## ORGANIC REBATES AND SUPPLEMENTAL FEE EXPLAINED

### The Federal Organic Cost Share Program

This program currently reimburses certified growers and processor/handlers 50% of their certification costs, to a maximum of \$500 per certification scope. Funds come from two sources. In Maine, funds for cost share payments to organic producers (farmers or growers) come from the Agricultural Management Assistance (AMA) Organic Certification Cost Share Program. The AMA is available exclusively to producers in the 16 states that have a historically low participation rate in the Federal Crop Insurance Program. The AMA has been a stable source of cost share funding, regardless of Farm Bill related negotiations. The National Organic Certification Cost Share Program (NOCCSP), which is a Farm Bill program, provides the funds for the organic cost share to the entire USA, including the organic processors and handlers in Maine. Currently there is funding for both programs, though USDA did reduce the maximum reimbursement amounts in 2020 to 50% up to \$500 per scope. In the fall of 2021 the **Organic and Transitional Education and Certification Program (OTECP)** was made available for producers through local FSA offices. OTECP provides certified producers with an additional 25%, to a maximum of \$250 per scope, in rebates toward certification fees paid in 2020 through 2022.

The State of Maine Department of Agriculture requests the funds from the USDA and generates the cost share reimbursement to Maine's certified organic producers. **The funding cycle runs on the federal fiscal year, which is October 1 through September 30.** Most cost share payments are sent to producers between September 15 and December 31, reimbursing certification costs incurred during the prior federal fiscal year. Every producer must file a type of W-9 form with the State called a Vendor Authorization form in order to receive a reimbursement. **Important: if your company name or address changes, you need to file a new W9 form with the state.**

MOFGA Certification Services provides certification payment data to the State for our certified clients; **however, we do not handle any cost share funds or payments.** We recommend that you contact the State's program directly if you have any questions:

The scope calculation works this way. We take what you paid for certification and divide it by the number of certification scopes you have. If you are a livestock producer, chances are good you are certified for two scopes (livestock and crops (for your hay, pasture, etc.)). **Note: additional scope fees apply if gross income exceeds \$60,000.** As an example, if you paid \$925 for certification, your cost share amount is calculated as follows:

\$925 divided by 2 scopes equals \$462.50 per scope. 50% of \$462.50 = \$231.25. The rebate amount for two scopes is therefore \$231.25 times 2 or \$462.50, so your total certification cost is \$462.50.

The scope's cost share calculation gets interesting when fees exceed \$1000 because the \$500 cap is applied to each scope, not the whole fee. Here is an example. A producer has fees of \$1925 and is certifying two scopes (livestock and crops). The total fees with scopes are \$2075. \$2075 divided by 2 equals \$1037.50. 50% of \$1037.50 is \$518.75. Here the cap of \$500/scope would apply, so \$500 x 2 = \$1000. You get a cost share check of \$1000, so your total certification cost is \$1,075.

### MOFGA's Rebate for Small Producers

To further offset the cost of certification for small organic producers, MOFGA offers an additional rebate which is available only for farmers and processors who gross less than \$10K per year in organic sales. MOFGA issues the payment for this rebate at the end of the year from information provided by MOFGA Certification Services. If you are in these income categories and are interested in this rebate, please make sure you check the MOFGA rebate box on the fee sheet. This is an optional rebate program.
